Washington state courts' General Rule 34 (GR 34) establishes who is eligible for a waiver of the filing fee to begin your civil case and other, mandatory charges What is special about Rule 34? • Before Rule 34 was created in 2010, each court was free to come up with its own criteria for waiver of the filing fee There was no statewide Filing Fee Waiver
